As an apostolate FOCUS desires to evangelize through all means, and to steward our resources in support of this aim. One resource of FOCUS is the album "Origin (a beauty initiative within FOCUS)". FOCUS created this album and therefore owns the actual recording of the music. Yet we desire to make good use of this product and to make it available to like-minded users. We also are committed to following all copyright laws as a matter of justice toward the composers and copyright owners. Therefore, the process for requesting use of the music depends upon the nature of your media project, whether is it non-commercial or commercial.

NON-COMMERCIAL SYNCHRONIZATION LICENSE

For FOCUS staff and students, as well as others wishing to make use of this music for non-commercial reasons – meaning that you are not receiving payment or profit for said project – we are happy to offer all the usage rights in our possession. Origin was created as a response to evangelize through beauty, and we desire that this project be shared broadly.
